Notes from the President's Corner

For the past several months I have been reporting on the status of the many capital projects we have on the go. Most of the decisions have been made. Next month, the Lindsay Construction survey team should be on site to start the process of constructing a new building over a section of our existing sawmill building.

Equipment wise, our first challenge will be to build a new log brow and log infeed system to the debarker. Part of the new building will go through the existing log brow. This has also been a complicated process, but our team now thinks we have ironed out most of the details.

The transformer pad mount for the existing transformer needs to be relocated and upgraded to a larger one. The wiring to the present transformer and the new one will be fed underground. This is also very complicated and needs to be done in conjunction with the concrete work for the addition to the sawmill building.

Our new boiler building also requires an addition to accommodate our new boiler. The new addition will encroach on the present steam tunnel going from the boiler room to the planer mill. The pipes in the steam tunnel are 25 years old and this presents an opportunity to move the tunnel somewhat away from the new building and replace it with new piping. In conjunction with this project. and because communication wiring has been a challenge over the years, new pipes and wires will be installed from the boiler room to the sawmill and from the boiler room to the planer mill.

Life Safety Systems has completed the sprinkler system in the planing mill and are now moving to install the sprinkler system in the bin sorter building. When the new sawmill building is erected, Life Safety will continue their work to complete the sprinkler system throughout the entire sawmill. Upon completion of the boiler room addition, the sprinkler system will be extended throughout the new portion of the building.

Notes from the President's Corner, con't

Our goal is to have all our production facilities fully sprinklered by the end of this year!

I am still working diligently towards the construction of a biochar plant here at Elmsdale Lumber. process to rezone part of our property and obtain a development agreement with the Municipality of East Hants has turned out to be a long, engaging process. A question was raised as to whether we need to do an environmental assessment. Strum Engineering has determined, after a long, extensive study, an environmental assessment is not required. Department of Environment, after studying Strum Engineering's report, have also concluded assessment is not required. By the end of next week, I anticipate we will have addressed all the concerns raised by Councillors, municipal staff, and the public. The next step is to host a public hearing, followed by approval or disapproval from the Municipality. This should take a month or two. Keep posted.

COVID 19 and the numerous variants continue to ravage our province. Throughout most of the pandemic, Nova Scotians have adhered to the protocols and have managed to keep our province in better shape than most places in the world. The new variants have presented new challenges and have resulted in a new lock-down. Nova Scotians have beat this before and we will beat it again. Please continue to safeguard yourselves, your families, and your job by following the recommended procedures of Dr. Strang.

Chris and I, along with others here at Elmsdale Lumber, have received our first dose of vaccine. I am sure your time will come before too long. I urge everyone to get the vaccine. Vaccines are the key to getting out of this horrible mess!

Lumber, as well as panel prices, continued to set records in the month of April. Most mills are now quoting late May/early June with prices well above last Friday's Random Lengths print. Prices are being quoted \$100 to \$150 above print depending on the item. 2x4 and 2x6 10' prices are extremely high and almost impossible to find.

Eacan's reload business out of Dartmouth, as well as our US reloads, continues to be very busy. For our customers, it seems to be a matter of "what do you have and when can I get it ", as opposed to pricing? With this kind of demand in North America pricing should continue for the month of May. Currently, there is no indication of a slowdown. So, strap on and enjoy the ride as the trip back down won't be as much fun!

Notes from Woodlands, con't

Despite a bit of rain lately, conditions in the woods are drying out surprisingly fast. The consensus seems to be this is a result of a lack of snow accumulation this past winter. This has subsequently allowed for slow but steady deliveries during road closure. The roads re-opened on April 26 for Colchester County to Yarmouth County with the remainder of the province scheduled to reopen this Monday. However, as we enter late spring, the demand for sawlogs and stud wood remains high which will require acute attention to the ebbs and flows of the contractor and supplier base.

Sometime in May we plan to pick up where we left off last fall with planned harvest operations on the Mi'kmaw Forestry Initiative St Croix lands. In 2021, this partnership will see us participate in the completion of a 250-acre commercial thinning, as well as an irregular shelterwood harvest trial operation. The trial area will see us test a treatment that will be implemented on Crown Lands going forward on the Matrix component of the triad model. From the perspective of the Department of Lands and Forestry, the harvest trial which is setup by their Forestry Division will establish permanent sample plots to study the results of the treatment over time. The harvest trial also provides a platform to evaluate productivity measures from a contractor perspective and the feasibility of such treatments going forward. We are pleased to have the opportunity to participate in what we feel may contribute towards implementing the triad approach to forestry successfully.

Lastly, like many folks this time of year, I am looking forward to getting in a little fishing. Although the latest COVID 19 restrictions may require some modification to those plans, I am sure I will still enjoy trying my luck for trout within government COVID protocols. So, for those who plan to do the same, let's hope for good times and tight lines safely.
